SUGGESTED FIELD TRIP

If we could get together and share a field trip outing this month, we would be going to Bolsa Chica Ecological Preserve in Huntington Beach, across PCH from Bolsa Chica State Park. Bolsa Chica is one of the great local birding spots. Ducks, shorebirds, and waders can be found in abundance. Gulls, terns, and pelicans are regular, as are raptors that nest on the bluffs.

If you can safely get out and travel, this winter birding spot is well worth your time.

Salton Sea Public Health and Environmental Protection Act

Rep. Raúl Ruiz, M.D. (D-Palm Desert) introduced a bill promising restoration efforts and public health measures for the Salton Sea.

The Salton Sea Public Health and Environmental Protection Act of 2020 would codify a 2016 memorandum of understanding between the state of California and the federal government to collaborate on habitat and dust suppression projects at the Salton Sea to avoid and minimize harm to people and wildlife due to the shrinking sea.

It also would require the U.S. Dept. of the Interior to match efforts by California to implement restoration and dust control projects, enhance interagency coordination, expedite permits, and require reports to Congress and the public about public health hazards and progress of mitigation projects.

The bill aligns with the Biden Administration's four priorities of COVID-19, climate change, racial equity, and economic recovery. Vice-president-elect Harris and her office have been briefed on this

<u>Unprecedented Rollback</u> of Bird Protections <u>Cemented in</u> <u>Administration's Final</u> <u>Days</u>

Earlier this week the Department of the Interior released its Final Record of Decision which officially strips away critical protections in the Migratory Bird Treaty Act (MBTA), giving industries a free pass to kill birds. The finalized rule change overturns decades of bipartisan precedent and eliminates bird protections at a time when populations are at serious risk from long-term declines and climate change. Now is the time to show your support for the MBTA by calling on the new Congress and Interior Department leadership to reinstate bird protections.
